- e) The members of the public of institutions acting through their representatives who contribute Rs.5,000/- (rupees five thousands only) and above are designated as 'Sahayakas' and
  - f) The members of the public or institutions acting through their representatives who contribute Rs.1,000/- (rupees one thousand only) and above are designated as 'Aajeewa Sadasyas'.
7. a) The first trustees will hold office for 5 years. At the end of the 5th year all the trustees shall retire and there will be a fresh election for 15 trustees from among the first trustees. If there is any shortage in number of such trustees it shall be filled in from among the Abhimanis in the usual procedure of election.
- b) 'Mahaposhakas' shall be trustees for life. In case of death of any mahaposhaka his eldest male descendent in the male line and failing him any other person in his family who in the opinion of the remaining trustees might be fit to act as such trustee shall be trustee in his place.
- c) Poshakas shall be trustess for life.
- d) There will be 5 trustess in each catagory of 'Abhimanis', Sahayakas and Aajeewa Sadasyas elected by all the members of the Trust.

After the end of the 5th year there shall be 30 trustees in total excluding Mahaposhakas and poshakas represented by each class as follows:

9. The trusteeship of a person shall terminate on resignation or death. Such vacancies shall be filled in by co-option by the remaining trustees.

10. The trustee shall have power to frame rules from time to time:-

- a) for the conduct of their meeting and business.
- b) for facilitating the carrying out of objects of the Trust.

11. Without prejudice to the generality of the foregoing the Trustees shall have power:-

1. a) To obtain and secure in the name of the trust any immovable or movable properties by purchase, lease or grant and to own and possess the same.
- b) To borrow money with or without securities and expand the funds for purpose of the trust, raise any fund by issue of debentures or otherwise on the security of such property which the Trust may acquire and make provisions and arrange payment of the same including interest thereon provided however that the Trustees shall not in any way be personally liable for any such debts.
- c) To sell, mortgage, grant on lease, hire or otherwise alienate the properties of the Trust for the benefit of the Trust
- d) To open Bank Account or Accounts and arrange operation thereon by any two of the following office bearers jointly:
  1. President, 2) Secretary, 3) Treasurer/
- e) To enter into contracts and rescind the same.
- f) To invest the funds of the Trust in such manner as they deem fit and as provided in the Income-Tax Act, 1961.
- g) To construct any buildings on any land belonging to the Trust and improve, alter or repair any buildings which may be acquired in the name of the Trust or taken on lease or rent.
- h) Meetings of the trust shall ordinarily be held not less than once in three months, or as often as may be necessary, on such date, time and place as may be fixed by the Secretary with the consent of the President

for the purpose of transacting the business of the trust. The Board shall authorise the Secretary to call the meetings of the Trustees and generally Body meetings. Four days notice shall be given for the meeting. The quorum for meetings shall be five, provided that, no quorum shall be required for a meeting adjourned for want of quorum. If a meeting is to be postponed for want of quorum it shall stand adjourned to the same time, same day of the next week at the same place and the members present for such meeting shall be the quorum.

2. The Board of Trustees shall have power:-

- a) To employ necessary staff, fix their remuneration, terminate their services, suspend or otherwise deal with them.
- b) To appear and act before all Government Authorities and Courts and Tribunals,
- c) To institute and defend all suits and proceedings,
- d) To apply the properties and funds of the Trust for purpose of the Trust,
- e) To raise funds and receive donations for carrying out the purpose and objects for the trust.
- f) To be responsible for the Organisation, Management and Administration of the Trust,
- g) To incur necessary expenses for carrying out the above objects.

12. The President of the trust shall preside over all the meetings of the trustees. If he is not present, or if present, but is not able to preside, the Vice President in the order of seniority shall preside. If none of them are present then the trustees may elect one among the trustees to preside over the meeting as its Chairman. The Chairman shall have a casting vote in case of equality of votes.

13. The business of the trust may also be transacted by getting the consent or otherwise of the trustees by circulating the agendas.

14. All ~~business~~ decisions of the trustees shall be by simple majority except as otherwise expressly provided herein.

15. True and correct minutes of proceedings of the meetings shall be maintained.

16. The trustees shall maintain true and correct account in respect of their transactions connected with the trust and the same shall be got duly audited annually by a Chartered Accountant.

17. The trustees shall apply such sums of money as may be available from time to time by way of income from properties of the trust as well as donations, contributions and gifts from the public including institutions to carry out the aims and objects of the Trust under this deed.

18. The trustees shall be kept fully indemnified by the trust against any claim or liability arising against them for any act done by them in good faith pursuant to the power and authority vested in them under these presents.

19. Any amendment to this deed of trust may be made by a resolution passed unanimously or with 3/4ths majority of all those who have contributed to the trust and present at a meeting convened for that purpose provided however that neither the name nor the basic character of the Trust shall be altered. The quorum for such a meeting shall be five.

20. In the event of the trust ceasing to function and if 75% or more of all those who have contributed to the trust feel that the trust cannot be revived and worked, the funds and properties shall be handed over to another trustee or institution whose objects similar to those of this trust, but in no case the assets of the trust shall be distributed among the trustees or donors.

21. The account of the trust shall be closed on 31st March of every year.

22. The office of the trust shall be at Bangalore for the present at 15 Vasavi Temple Road, Bangalore 4.
